1. For the hand sanitizer do you require it in gel or liquid form?  
Quote for both gel and liquid and clearly point out on the quotation.

2. Can one opt to bid for only one item/lot say the hand sanitizer alone?

3. For the bid bond of 2million – this is applicable for all the 3 lots or it can be reduced based on lot-by-lot basis.  
If you are bidding for one item, please issue a bid bond of 10% of your bid price
